This Addendum is made to the Agreement between Board of Education of Barrington CUSD 220, Lake, Cook, McHenry, Kane Counties, Illinois ("District") and Garvey's ("Contractor") executed 3rd day of June, 2025, and now amended by mutual agreement by the parties as follows:

1. Contract Term Extension – Pursuant to the original bid documents, the Contractor's current contract with the District shall extend until June 2nd, 2027.
2. Cooperative / Participating Agencies – This extension applies to the Master Agreement and shall be available to all Participating Agencies and eligible entities utilizing the contract pursuant to the cooperative procurement provisions set forth in the original Bid Documents and Agreement. All such entities may continue to utilize the contract under the same terms, conditions, and pricing structure.
3. Economic Adjustment – As outlined in the original bid documents, the Contractor has elected to make a price adjustment in line with the original bid specifications. New prices are attached to this addendum and are effective for orders placed on or after June 3rd 2026.
4. No Other Changes – Except as expressly modified herein, there are no material changes to the scope of services, terms, conditions, or obligations of the parties. All other terms and conditions of the Agreement, including all Bid Documents incorporated therein, remain unchanged and in full force and effect. This Addendum and any preceding amendments are hereby incorporated by reference into the Agreement as if fully set forth therein.

All other terms and conditions remain unchanged and in effect. This Addendum and any/all preceding amendments to the Agreement are hereby incorporated by reference into the original Agreement executed 3rd day of June, 2025, as if fully rewritten therein.
